### Preface

The **IAQwi\$e Certificate** is one of the certificates of the Hong Kong Green Organisation Certification (HKGOC) scheme. HKGOC aims to benchmark green organisations with substantial achievements in green management, to encourage participants to adopt environmental practices in different aspects and to recognise their efforts and commitments to the environment. It is a prestigious certification scheme with high credibility. It also encourages participants to strive for self-improvement in specific environmental aspects.

The HKGOC is led by the Environmental Campaign Committee (ECC) alongside the Environmental Protection Department and in conjunction with nine organisations, in alphabetical order, the Advisory Council on the Environment, the Business Environment Council, the Chinese General Chamber of Commerce, the Chinese Manufacturers' Association of Hong Kong, the Federation of Hong Kong Industries, the Hong Kong Chinese Importers' & Exporters' Association, the Hong Kong Council of Social Service, the Hong Kong General Chamber of Commerce and the Hong Kong Productivity Council.

Starting from 2020, HKGOC consists of four Certificates, namely "Wastewise Certificate", "Energywise Certificate", "IAQwise Certificate" and "Carbon Reduction Certificate". The first three Certificates encourage initiatives on waste reduction, energy saving and improvement of indoor air quality (IAQ) respectively and recognise participating organisations that have attained specified environmental requirements and achieved self-improvement goals. In addition, the Carbon Reduction Certificate recognises organisations with quantifiable carbon reduction achievements.



Organisations applying for these Certificates will be required to demonstrate their commitment to environmental protection in specific aspects in order to be granted a respective Certificate. Organisations can join any of the HKGOC Certificates at any time and there is no limit for the number of awardees for the certificates. Certificate holders can further obtain the title of "Hong Kong Green Organisation" by attaining the requirement in multiple aspects of environmental practices and the details could be found in the separate programme booklet of "Hong Kong Green Organisation". In addition, participants are highly recommended to educate others, including organisations in the same sector and the community at large, on the benefits and practices of other environmental initiatives.

This **IAQwi\$e Certificate Guidebook** is designed for use by all companies / organisations operators which have offices and public places in Hong Kong. It details the IAQwi\$e Certificate rules, process and benefits of obtaining the Certificate. Furthermore, this Guidebook presents an overview of sustainable indoor air quality practices that companies / organisations could implement within their establishments. All companies / organisations are welcome to join this meaningful Certificate to demonstrate their commitment to creating a better environment for Hong Kong.

### 1. INTRODUCTION

### 1.1 Why is Indoor Air Quality (IAQ) Important?

On average, we spend more than 70% of our time at homes, in offices and other indoor environments. The polluted indoor environment may give you a headache, itchy eyes, respiratory difficulties, skin irritation, nausea and fatigue. Those with existing respiratory or heart disease are more susceptible to the effects of indoor air pollution. Improved indoor air quality can result in higher productivity, fewer lost workdays and better companies / organisation.

### 1.2 What Can Companies / Organisations Do?

Many premises in Hong Kong have been awarded IAQ Certificates issued by the Environmental Protection Department (EPD). The premises / building owners or management have realised that good IAQ in offices and public places could:

- enhance the comfort level of the occupants
- increase the productivity of the workers
- attract more tenants or customers

In addition to the IAQ Certification Scheme under the "IAQ Management Programme" run by EPD, the premises / building owners or management can further enhance the IAQ at offices and public places beyond certification requirements of the IAQ Certification Scheme by joining the **IAQwi\$e Certificate** of **HKGOC**.

### 2. THE IAQWI\$E CERTIFICATE

### 2.1 Objectives of the IAQwi\$e Certificate

The **IAQwi\$e Certificate** is established to encourage and recognise participants implementing or achieving IAQ standards beyond certification requirements of the IAQ Certification Scheme under the "IAQ Management Programme" to further enhance IAQ at offices and in public places in Hong Kong.

### 2.2 Co-operation Structure

The Environmental Campaign Committee (ECC) is the Organiser of the HKGOC in association with other joint Organisers. IAQwi\$e Technical Consultant (Technical Consultant) is responsible for coordinating, assessing and assisting the organisations that join the Certificate. A Technical Consultant will work with each applicant and help them to check against what IAQ improving measures have been implemented in their companies / organisations, and will educate them on what extra measures can be taken for future improvement.

### 2.3 Eligibility to the IAQwi\$e Certificate

The Certificate is open to offices and indoor public areas of local companies and organisations as well as their functional units that primarily operate within Hong Kong. The applicant should plan to apply / hold a valid IAQ Certificate issued by a Certification Issuing Body under the IAQ Certification Scheme for Offices and Public Places (IAQ Certification Scheme) implemented by the EPD.

### 2.4 IAQwi\$e Certificate Benefits

The **IAQwi\$e Certificate** is to recognise companies / organisations for their commitment and effort in environmental protection through better IAQ. By joining and fulfilling the Certificate requirements, Certificate members can enjoy many benefits, such as -

### Enhancing Productivity and Competitiveness

IAQ improvement measures help increase business competitiveness by attracting those customers who value conducting business with companies that are committed to improving environmental quality as well as to enhance corporate image.

### Obtaining Technical Assistance on IAQ Practices

IAQwi\$e Certificate participants will have the help and support from the Technical Consultant when needed. Enquiries can be made through the Certificate helpline. All assistance given by the IAQwi\$e Technical Consultant is <u>free of charge</u>.

### Main Improving the Quality of Life

Everyone strives to live a comfortable and enjoyable life. Better IAQ can help create a better quality of life for all.

### Marding Prestigious IAQwi\$e Certificate

The Certificate is synonymous with demonstrating exceptional leadership within the environmental arena and can be used for promoting Certificate holders' achievements regarding improving IAQ.

### Recognition and Publicity of Good IAQ Achievements

Becoming an IAQwi\$e Certificate participant means entering into a partnership with the Government to achieve common environmental objectives. The ECC may commend certificate holders for their efforts through publicity and marketing activities that will make their environmental achievements and contributions known to the public.

### **Participating in HKAEE**

Certificate holders can also achieve relevant bonus points in the Hong Kong Awards for Environmental Excellence (HKAEE), which is an annual award led by the ECC, aiming to recognise the overall environmental achievements of an organisation. Details of the HKAEE are in the HKAEE Programme Booklet on the HKAEE official website (http://www.hkaee.gov.hk).


### 3.1 Certification Criteria

### 3.2 Certification Process

Companies / organisations can join the Certificate all year round. Various stages of certification process are illustrated in the following flow chart.

### **Application for the Certificate**

To apply for the IAQwi\$e Certificate, companies / organisations should complete the Application Form (IAQ/01R) in this Guidebook and return it to the Technical Consultant. Once the application has been processed, the applicant will receive a unique IAQwi\$e Membership Number. This number will represent the organisation and will remain throughout the duration of its participation in the Certificate, it will be used in all future correspondence between the member, the ECC and the Technical Consultant. Membership can last as long as companies / organisations comply with the IAQwi\$e Certificate requirements. All applications are free of charge.

#### **Initial Review**

Initial Review will be scheduled with first-time participants to fully explain the aim, the process and different requirements of each level of the Certificate. Technical Consultant will assist the participant in pursuing various levels of the Certificate, which are "Basic" Level, "Good" Level and "Excellent" Level.

### Identification of Implemented Measures

Participants are required to submit the IAQwi\$e Assessment and Reporting Form (IAQ/03R) to demonstrate their compliance with the related requirements according to the level of Certificate which it wishes to pursue. They need to report the certification status at the EPD's IAQ Certification Scheme (for Good and Excellent Level) or their plan to join the Scheme (for Basic Level), as well as the achievements in enhancing the IAQ standard over the past 12 months, or the educational / promotional programmes that have been implemented. This process should be completed within two months after the participant receives its IAQwi\$e Membership Number or completes the previous implementation cycle.

#### **Verification and Reporting**

An on-site visit will be scheduled and conducted by the Technical Consultant for all new participants to verify the accomplished measures, whereas a random on-site visit will be arranged for all existing Certificate holders. The participant is required to provide information / evidence to demonstrate compliance with the requirements of the target level that it pursues. The Technical Consultant will finalise the Assessment and Reporting Form (IAQ/03R) to report the achievements that the participant made. The ECC Secretariat and Technical Consultant will jointly determine the level of Certificate that the participant achieved.

### **Final Endorsement**

Reports will be submitted to the ECC Secretariat for final endorsement.

### Award of Certificate

The validity of IAQwi\$e Certificate is <u>one year</u> from the date of Certificate accreditation, subject to renewal<sup>2</sup> or advancement to a higher level(s) or the expiry date of the IAQ Certificate issued by the Government, whichever is earlier. Granting of IAQwi\$e Certificate to successful participants will take place quarterly.







# 4. IAQWI\$E CERTIFICATE MEMBERSHIP AND USE OF CERTIFICATE

### 4.1 IAQwi\$e Certificate Membership

IAQwi\$e Certificate members may be granted one of the three levels of Certificates, namely "Basic" Level IAQwi\$e Certificate, "Good" Level IAQwi\$e Certificate, and "Excellent" Level IAQwi\$e Certificate. The three Certificates are synonymous with a high commitment to achieving good and outstanding IAQ respectively in Hong Kong. Companies / organisations that display the Certificates will be recognised by customers, suppliers and business partners for their good work in improving IAQ. Furthermore, IAQwi\$e Certificate members will benefit greatly from the publicity on the attainment of the Certificates.



### **Certificate Validity**

Each Certificate granted to IAQwi\$e Certificate member is valid for <u>one year</u> or the expiry date of the Indoor Air Quality Certificate issued by the EPD, whichever is earlier.

### **Reactivation of Membership Status**

For those members who fail to renew their Certificate, they can reactivate their membership status if they rejoin the Certificate within three years from the expiry of their Certificate and their Certificate status can remain unchanged.

### 4.2 Use of Certificate

The Certificate holders are encouraged to use the Certificate, which will be distributed to Certificate holders upon certificate conferment, on their premises, publicity materials or advertisement, etc. The Certificate holders shall at all times –

- Comply with the certification criteria. The ECC may amend the criteria from time to time and the Certificate holders shall fulfill the amended accreditation criteria within the time specified by the ECC;
- Allow the ECC to make publication or announcement about the successful application, suspension and
   / or termination of accreditation status for the Certificate;
- Represent honestly and truthfully to any person concerned that it is only accredited for the scope and status as stated in the Certificate; and
- Endeavour to ensure that the certificate granted by the ECC is not used in a misleading manner or in a way that will bring the ECC or the Certificate into disrepute.

The ECC may, at its sole and absolute discretion, terminate the accreditation status of a Certificate holder for any of the following reasons –

- There is reasonable ground to believe that the Certificate holder concerned does not have genuine intention to honour and discharge its obligations under the Certificate;
- Y The business concerned has been adjudicated bankrupt; or faces a winding-up order;
- The Certificate holder concerned is behaving in a dishonest or fraudulent manner which jeopardises or damages the reputation or interests of the Certificate, the ECC, or the Technical Consultant; or
- Y The Certificate holder concerned ceases to carry on its business or operation.

The use of the Certificate and its related publicity means (such as logos, right to use at participant(s)' website, name card, etc.) rested with the explanation of the ECC Secretariat and in accordance with the relevant guidelines about the usage of the Certificate(s) and Logo(s).

In the event that the certification status is terminated or not renewed, the Certificate holder shall immediately cease the use of any advertisement bearing the Certificate.



### 4.3 Final Message

Hong Kong's growing IAQ problem can be controlled if everyone takes actions to improve the indoor air condition. Companies / organisations in Hong Kong can play a leading role in improving IAQ and hence improving environmental quality by joining efforts such as joining the IAQwi\$e Certificate. The IAQwi\$e Certificate has been designed to aid companies / organisations in the development of IAQ improvement measures and goals as well as recognise their efforts. Essentially, companies / organisations can benefit from gaining recognition and publicity by joining the Certificate. The Certificate provides a win-win situation for both Hong Kong's environment and businesses alike. Every company / organisation in Hong Kong is encouraged to join.

### Step 1: Establish the Driving Force


- Y Appoint "IAQ Manager" to coordinate, keep track, and oversee IAQ improvement programmes.
- Engage "IAQ Certificate Issuing Body" (IAQ CIB).
- Y List of accredited IAQ CIBs (http://www.iaq.gov.hk/en/iaq-certification-scheme/certificate-issuing-body-accreditation.aspx)

### Step 3: Develop IAQ Management Programme

Indoor air quality is the result of the interplay of many different and often very complex factors unique to each building. It is not a subject which is susceptible to prescriptive policies. Actions which may improve air quality in one building will not necessarily improve it in another. In order to prevent and deal with IAQ problems it is therefore necessary to create an IAQ Management Programme specific to the building.



### Step 4: Set Up IAQ Objectivities

 $^{st}$  Set up Health-based benchmark for evaluating and assessing IAQ based on TAQ Certification Scheme .

Encourage building owners to aim at the best IAQ.

### Step 5: Regularly Analyse and Review

- Y IAQ Manager should regularly maintain and analyse relevant records to keep track of the IAQ monitoring results.
- Review IAQ management programme regularly to identify any areas for further improvement.
- Regularly publish IAQ monitoring results to maintain employees' momentum and enthusiasm.



### Step 6: Promote Awareness of Indoor Air Quality

- Promote employee's awareness on the IAQ management programme and / or specific IAQ improvement measures by different channels of internal communications.
- Y Introduce IAQ management programme to newly joined staff during orientation.

#### **Suggestion 1: Facility Maintenance**

- 1. Filters
- Replace dirty filters frequently to avoid accumulation of dust and prevent blockage.
- Check filters in air-handling units regularly to ensure filtering efficiently.
- Contact manufacturers when filters fail to meet the equipment specifications.
- Check if it is securely installed in device without air not being filtered.
- Check if pre-filter and final filter are installed properly.
- Check if filter display / alarm is installed and operating properly.
- Make sure filters are regularly cleaned & replaced.

#### 2. Air Movement, Intakes and Return Vents

- Avoid furniture and other materials near intake/return air vents may affect air flow. Make sure dampers are operable and air intakes are not blocked.
- Pollutant sources, e.g. idling vehicle emissions and furnace exhausts, etc., should be 10 m away from air intakes.
- Chemicals & pets should not stay near air vents.
- Ensure louvres are not covered/blocked.
- Photocopiers & laser printers should be located at independently ventilated/properly ventilated areas since ozone will generate during operation.
- If your workplace is either hot, cold, stuffy or draft, notify the building management according to your office's procedures.
- Check stainless steel wire gauze's status
- Check potential sources of pollution near the fresh air entrance (e.g. exhaust gas, garbage collection stations, bus stops, etc.)
- Y System should be regularly cleaned & replaced

#### 3. MVAC system and Exhaust Ventilation

- Use tissue paper/smoke testing for local exhaust systems inspection to assure air is being exhausted to the outside.
- Maintain exhaust fan in good condition
- Ensure to keep clean and dry
- Do not store chemicals/garbage
- Ensure the drainage is not blocked

#### Suggestion 2: What everyone Can Do

#### 1. Regular Cleaning

- Clean building when it is unoccupied/out of office hours.
- Select products with no/ low volatile organic compounds.
- Clean water spills and remove mouldy materials immediately to minimise mould growth.
- Dried traps can emit sewer gases, check the drain traps are filled with water regularly.
- Water creates a hospitable environment for growth of microorganisms. Keep places dry.
- Often vacuum carpets (best for daily) particularly in heavy use areas.
- Purchase vacuum cleaners effective at capturing fine particles if possible.
- Avoid dry sweeping/dusting and clean hard surfaces with a damp cloth/mop.
- Discuss what should be cleaned more often.
- Dispose of garbage in appropriate containers that are emptied daily to prevent odors & biological contamination.

#### 2. Moisture Issue

- Leave space between furniture and walls (couple of inches)to allow air circulation and prevent moisture accumulation.
- Cut back trees & shrubs that are touching walls.
- Remove immediately by cleaning hard surfaces with nonammonia based detergent if mould appears.
- Moisture damaged materials should be dried or replaced within 2 days to prevent mould growth.
- Maintain humidity level through MVAC system and use of dehumidifier.
- Avoid condensation on walls, ceiling ,and floors.
- Use a hygrometer / humidity meter to measure indoor relative humidity & record.
- Through proper operation of the mechanical ventilation & air-conditioning system ,and the use of dehumidifier, maintain relative humidity of less than 70%

#### 3. Storage of Food

- Y Often clean the refrigerator to prevent odors.
- Do not store perishable food products in desk area.
- Keep kitchens and dining areas clean to prevent pests and maintain hygieneDo not store chemicals/garbage
- Follow "first in, first out" method, use ingredients that have been stored for a long time first.
- Remove visible mould regularly.

## 4. Notice the facility manager immediately when an IAQ problem exists

Help management determine the cause of the problem and solve it as soon as possible.

### Suggestion 3: IAQ Management Programme

#### 7-Steps of IAQ Management Programme

- Step 1: Allocation of responsibility
- Y Step 2: Preparation
- Step 3: Review of work contracts and procedures
- Step 4: Review of occupation contracts
- Multiplet Step 5: Communication
- Step 6: Investigation of complaints
- Step 7: Record keeping

### Suggestion 4: Green Procurement

- Look for and purchase carpet, cushion, or/and floor-covering adhesive with green label, e.g. the Carpet and Rug Institute (CRI) in collaboration with USEPA label, identifies the products that have been tested and met stringent IAQ requirements for very low emissions, which covers carpet, carpet cushion, and floor covering installation adhesives.
- Choose furniture that has low emission of formaldehyde. Furniture made of solid hardwood, solid softwood/softwood plywood coated with low-toxicity sealant to retard the emissions from the manufactured wood products is preferable. All exposed edges & surfaces should be thoroughly sealed.
- Apply low emission office equipment to reduce the impact on health and reduce contribution of indoor air pollutants, e.g. ozone, dust, and total volatile organic compounds to office.

### Suggestion 5: Clean Up Mould

- For moulds on hard surfaces/non-porous materials, wash them with cleaning detergent & water, then dry them thoroughly.
   For moulds on absorbent and porous materials (e.g. ceiling tiles and carpet) that cannot be cleaned, discard them in sealed
- plastic bag, clean the outside of bag, remove it from the mouldy area, then tie it in another plastic bag for disposal.
- Prevent dust generation during cleanup, e.g. gently misting mould-damaged wallpaper with dilute soap/detergent solution prior to removal.

### **Data Retention Policy**

This policy stipulates the kinds of personal data collected, means of collecting personal data, duration of retention, ways of using the personal data and data security measures for the HKGOC.

#### 1. Purpose of collection of personal data
